Introduction

The role of good governance and public accountability has been emphasized in recent years as a key to development effectiveness. For example, it has been argued that merely allocating public resources for right goods and services may not lead to desirable outcomes if institutions involving planning, management, budgeting and execution-are malfunctioning (World Bank 1998).

Globally, good governance and accountability has emerged as a high-profile issue and of critical interest for leaders, policy makers, managers, public and citizens and other stakeholders in health sector reform.

While there are substantial efforts in the country to deliver essential healthcare services to those who need them, progress have been slow despite availability of cost health interventions that can prevent much of the burdenofdiseases.

Lack of sufficient progress has been attributed to inadequate financial investment in health and accompanying varying degrees of health system failure which requires systems' solutions, which in many cases are temporary remedies which have been generally considered inadequate.
